Marlena MacNeill, Alcona Township Supervisor, provided the board with updated broadband information and the use of vertical structures to help extend internet coverage. MacNeill further requested that the Board maintain its decision regarding the PILT.

UNFINISHED BUSINESS:

Motion by Brummund, seconded by Brege to approve Resolution 2017-06 as follows:

RESOLUTION 2017-06

A CALL FOR ACTION IN RESPONSE TO GROUNDWATER CONTAMINATION IN OSCODA, MICHIGAN

WHEREAS, Michigan Department of Environmental Quality (MDEQ) and the federal government have identified multiple plumes of Polyfluoroalkyl Substance (PFAS) contaminated water migrating from properties of the former Wurtsmith Air Force Base (WAFB) located in Oscoda, Michigan; and

WHEREAS, MDEQ has confirmed that said PFAS contamination is impacting hundreds of private drinking water wells; and

WHEREAS, in response to potential human health risks, Michigan Department of Health and Human Services (MDHHS) has issued written advisories to recommend that people not drink or cook with water drawn from PFAS contaminated drinking water wells; and

WHEREAS, Michigan Public Act 545 of 2016 obligates the state or federal government that is or was the owner of the real property at the time a substance of concern was used on the real property, to provide an alternative water supply to the users of impacted water sources; and

WHEREAS, the Charter Township of Oscoda and Oscoda Wurtsmith Airport Authority have developed a discussion paper that identifies specific actions being requested on behalf of the community in regard to the groundwater contamination and related issues which is attached hereto for purposes of reference; and

NOW THEREFORE BE IT RESOLVED, Oscoda Wurtsmith Airport Authority does hereby appeal to the State of Michigan and the federal government for ensuring immediate and effective actions, including but not limited to compliance with and/or enforcement of State of Michigan Public Act 545 of 2016:

SPECIFICALLY, necessary actions and tasks are summarized as follows and will be expanded upon as more information becomes available:

- 1. <u>Initially Supply Bottled Water:</u> Immediately provide bottled water to impacted parties.
- 2. <u>Extend Municipal Water Mains and Connections:</u> Immediate and effective planning, contracting and construction so as to quickly extend municipal water supply mains to all homes, businesses and structures that currently utilize well water within impacted areas.
- 3. <u>Install In-house Water Filter Systems:</u> Likewise, move quickly to install "whole house" water filtration systems in locations where it is not feasible to provide connections to the municipal water distribution system.
- 4. <u>Flush Former WAFB Fire Hydrants:</u> MDEQ has identified PFAS contamination suspended within WAFB fire hydrants.
- 5. <u>Maintain Portions of WAFB Storm Drain System:</u> Federal government to operate and maintain the portions of WAFB storm drain systems that are utilized in support of groundwater treatment plant systems.
- 6. <u>Supply Funding for Professional Environmental Consultant Support Services:</u> Action items 1 through 5 above will benefit from the expertise and support services of professional environmental consultant service provider. Federal government to award a grant or establish a "Cooperative Agreement" in order to pay for said services or utilize whatever funding vehicle may be appropriate to accomplish this objective.

- 7. <u>Establish a Files Management Program:</u> Federal government to establish and fund a secure "Files Management Program" for storing and sharing all documentation generated during planning, testing and implementing of WAFB related environmental restoration projects.
- 8. <u>Indemnification Protection:</u> The federal government to provide a firm and unwavering commitment to immediately get in front of any lawsuits or other adverse actions that may arise so as to hold harmless, defend and indemnify the impacted property owners, impacted residents, the Charter Township of Oscoda, Oscoda Wurtsmith Airport Authority and its constituent municipalities, along with all successors in ownership and operation of former WAFB properties.
