December 28, 2018 The Detroit News; and

Whereas, Governor Whitmer has now circumvented the legislative process by Executive Directive No. 2019-9 which undermines the branch of the people (Michigan House and Senate); and

Whereas, The Michigan Legislative Bodies have not seen fit to expand the Elliot Larsen Act to include the re-definition of sex since 2005; and

Whereas, "that the opinions of men are not the object of civil government, nor under its jurisdiction; that to suffer the civil magistrate to intrude his powers into the field of opinion and to restrain the profession or propagation of principles on supposition of their ill tendency is a dangerous falacy, which at once destroys all religious liberty, because he being of course judge of that tendency will make his opinions the rule of judgment, and approve or condemn the sentiments of others only as they shall square with or differ from his own" — Draft of The Virginia Act for Establishing Religious Freedom January 1, 1779 Thomas Jefferson.

Therefore, Be It Resolved, that we the Alcona County Board of Commissioners would respectfully request Governor Whitmer to rescind this directive; and

Be it further resolved, That this matter be allowed to go through the legislative process which is accountable to the people.

Be it further resolved, That copies of this resolution be transmitted to the other 82 counties, the honorable Susan M. Allor 106th House representative Jim Stamas the 36th Senator Governor, Gretchen Whitmer and the other 82 Michigan Counties.
