RESOLUTION AGAINST PROPOSED BUDGET REDUCTIONS TO THE QUALIFIED FOREST PROGRAM

Whereas, Alcona County recognizes the importance of the Qualified Forest Program and the positive effects of the Forestry Assistance Program Foresters to the local economy and positive response of the public to the services offered by Forestry Assistance Program Foresters.

Whereas, the County of Alcona has been positively augmented by the presence of a Michigan Department of Agriculture funded Qualified Forest Program Forestry Assistance Program Forester.

Whereas, the State of Michigan has proposed budget reductions to the Qualified Forest Program.

Whereas, the County of Alcona is firmly opposed to any funding reduction that effects the quantity of Forestry Assistance Program Foresters.

Whereas, the County of Alcona is firmly opposed to any funding reductions to the Qualified Forest Program.

Now, therefore be it resolved, that the Alcona County Board of Commissioners is against the passage or enactment of budget reductions to the Qualified Forest Program.

Be it further resolved, that a copy of this resolution shall be transmitted to the Michigan State Senate, the Michigan State House of Representatives and the Governor of the State of Michigan.

VETERANS SERVICES GRANT FUNDING

WHEREAS, MCL 35.623a(5)(a), as amended, establishes a "base amount" of \$50,000.00 per County for "veterans service operations;" and

WHEREAS, MCL 35.623a(5)(b) provides for a "per capita amount" for the "number of veterans residing in each county;" and

WHEREAS, the plain language of MCL 35.623a(5) provides that disbursements to counties are to be determined by "combining" these amounts; and

WHEREAS, distinction between a "base amount" of \$50,000.00 per year and a variable "per capita amount" strongly suggests that the base amount may be interpreted as being fixed; and

WHEREAS, the statute can reasonably be interpreted to mean that the \$50,000.00 base amount would be ongoing, and would thus sustain County initiatives, provided the County complied with the provisions of MCL 35.623a; and

WHERAS, the Alcona County Department of Veterans Affairs has taken all steps prescribed by MVAA to achieve the eligibility requirements established in MCL 35.623a and thus to qualify for continued funding into the new fiscal year; and

WHEREAS, Alcona County has, in fact, relied on this "fixed" base amount in implementing plans for services to veterans, to wit, hiring one highly qualified full time Veterans Service Officer, with further plans to fund that individuals VA Accreditation Training; and

WHEREAS, the Michigan Veterans Affairs Agency has a long history of promoting an increase in the number of Veterans Administration Accredited Representatives to serve Michigan Veterans; and

WHEREAS, subsequent to disbursing the statutorily mandated funds for 2019, the Michigan Veterans Affairs Agency briefed the Michigan Association of County Veterans Counselors that the grant funding is programmed to be reduced to \$25,000.00 "base amount" for Fiscal Year 2020 due to funding constraints; and

WHEREAS, this reduction contravenes the plain language of the statute and will undermine steps taken by Alcona County to provide services to our veterans, and

NOW, THEREFORE, be it resolved, that the Alcona County Board of Commissioners urges compliance with the plain language of MCL 35.623a, and calls upon the State Legislature and the Governor to fully fund the County Veterans Service Fund Grant in FY 2020 and beyond; and

BE IT FURTHER RESOLVED that a copy of this resolution be forwarded to Governor Whitmer, Senator Stamas, Representative Allor and the Michigan Association of Counties.
