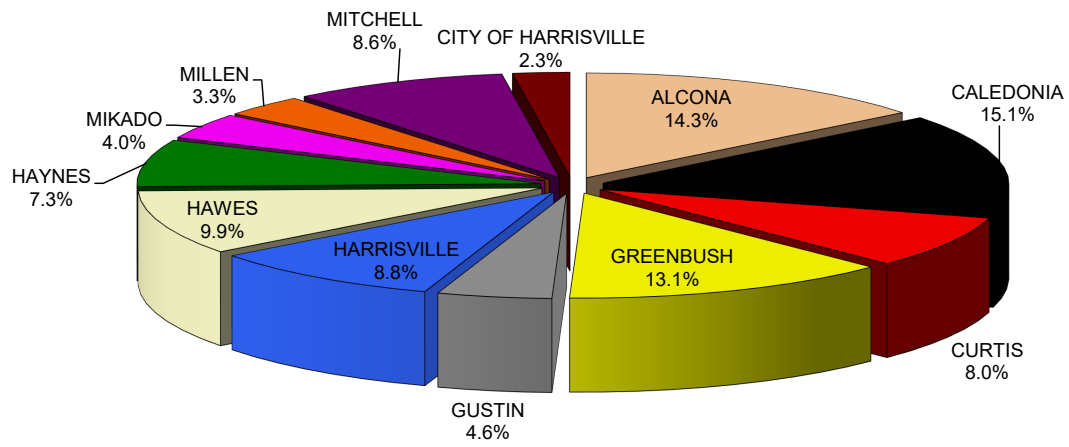

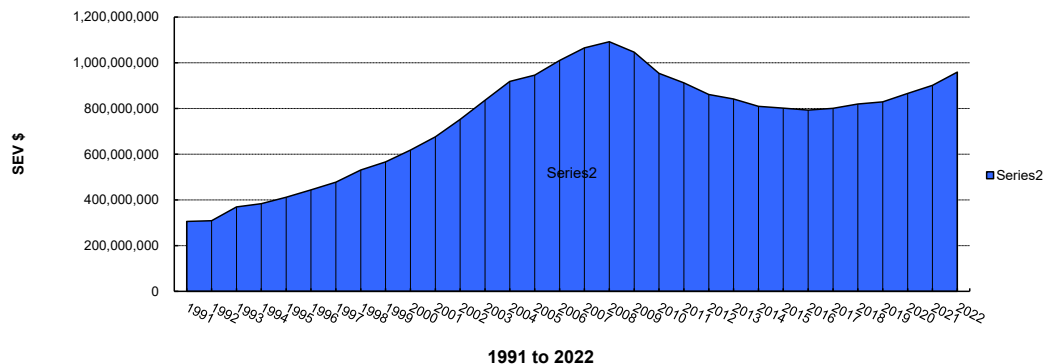

GROWTH CHART**

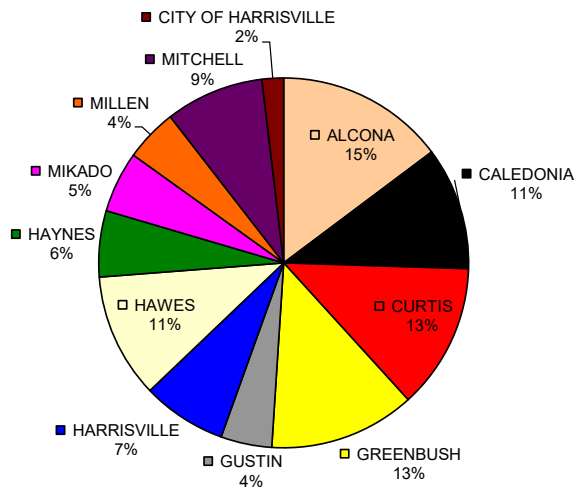

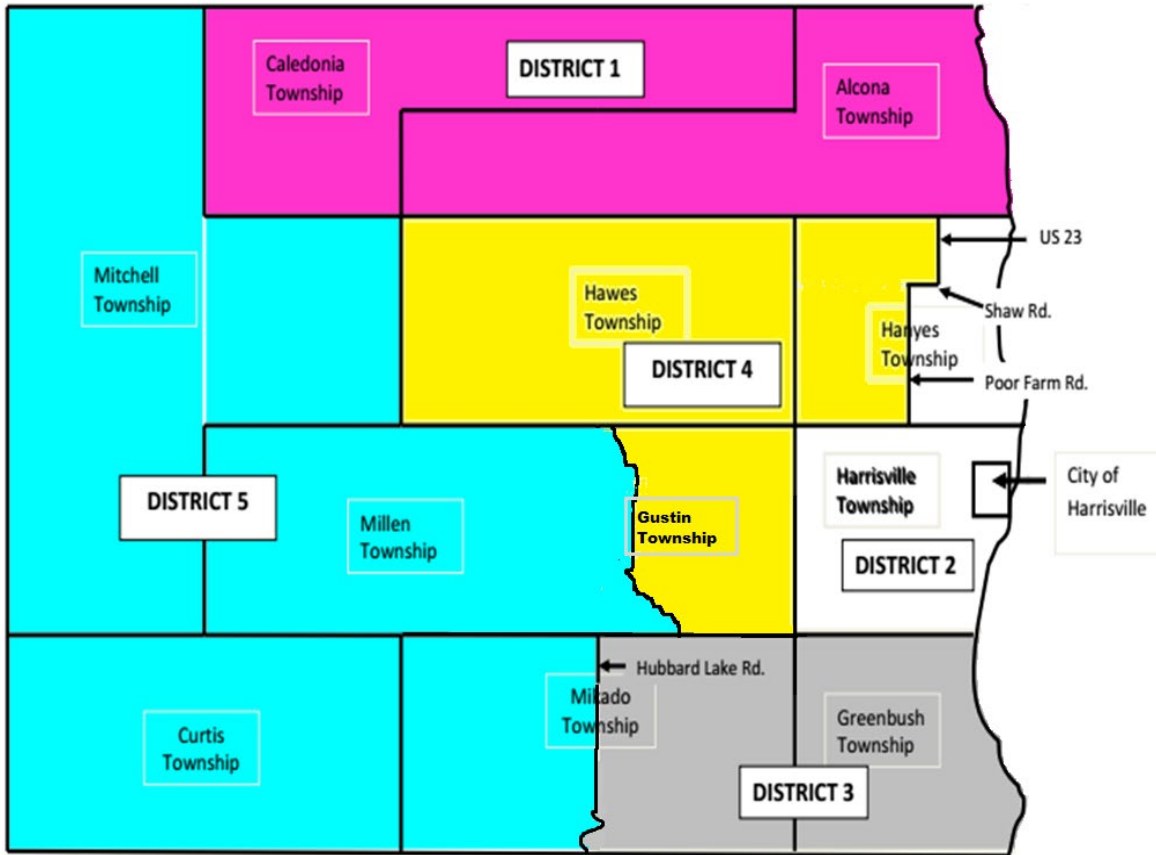
