

The **Special Meeting** of the Alcona County Board of Commissioners was held in the County Building in the City of Harrisville, Michigan on **Monday, September 26, 2022** at 3:00 p.m.

The meeting was called to order at 1:30 p.m. by Chairman, Adam Brege.

The Pledge of Allegiance was recited.

Commissioners present: Adam Brege, Chairman, Dan Gauthier, Vice Chairman, Carolyn Brummund, William Thompson and Terry Small. Also present: Stephany Eller, County Clerk and Cheryl Franks, County Treasurer.

Commissioner Brummund requested the Board approved the ratified EMS union contract as presented.

Motion by Brummund, seconded by Thompson, to approve the EMS union contract as submitted.

Discussion was held regarding wages for elected officials and non-union employees for FY 2023.

Chairman Brege discussed the County Clerk, Treasurer and Register of Deeds elected official's salaries in comparison to other counties, elected officials and department heads stating that Alcona's wages are at the bottom of the scale and proposed a new salary, along with the deputies.

Commissioner Brummund requested an increase for the Building and Grounds Department head.

Motion by Gauthier, seconded by Small, to increase the Treasurer, Clerk and Register of Deeds to \$53,200.00 and increase the deputies of the Treasurer, Clerk and Register of Deeds to \$46,200.00 and also Building and Grounds department head to \$46,200.00.

Motion by Brummund, seconded by Thompson, to increase the Prosecutor’s 2023 salary to \$90,000.00.

Motion by Gauthier, seconded by Small, to increase the Commissioners 2023 base pay to \$5,500.00 and \$6,200.00 for the Chairman.

Motion by Gauthier, seconded by Brege, to increase 2023 per diem for the County to \$50.00 for a half day and \$80.00 for a whole day.

Motion by Brege, seconded by Small, to increase the 2023 Board Liaison, Budget Liaison and Special Professional Services salaries by \$2,000.00.
